Change a Child's Story

ONCE UPON A TIME

In 1977, a Seattle juvenile court judge concerned about making drastic decisions with insufficient information conceived the idea of volunteers in the courtroom speaking up for the best interests of children who had experienced neglect or abuse. That judge was David W. Soukup. From the first program has grown a network of 940 CASA and guardian ad litem programs that are recruiting, training and supporting volunteers in 49 states and the District of Columbia.

CASA stands for “court-appointed special advocate.” CASA Advocates are volunteers, trained by supportive, accessible staff to advocate for the best interests of abused or neglected children during court proceedings. CASA Advocates are welcomed into courtroom proceedings and have the opportunity to truly change a child’s story.

MISSION

The mission of CASA of Hinds County is to recruit and train community volunteers to become court-appointed advocates for the best interests of abused or neglected children in the pursuit of safe and permanent homes.



CASA of Hinds County is a member in good standing with National CASA/GAL and CASA Mississippi.

Though numbers tell only a fraction of the story, today there are nearly 4,000 children in Mississippi's child welfare and foster care system: toddlers removed from their families due to abuse, abandonment or worse; children, who, having lost both parents, are separated from their siblings due to strain on the system; and teenagers who have spent nearly all of their youth shuffling from house to house and school to school.

In Hinds County alone, there were an average of 237 children in the foster care system in 2025, the second highest number of any county in the State of Mississippi.

JUDGE CARLYN HICKS, HINDS COUNTY YOUTH COURT

CASA of Hinds County serves under a court-order from the Hinds County Youth Court Judge, Carlyn Hicks. Individual foster care cases are assigned to CASA advocates by the order of the judge.

Judge Hicks is a lifelong resident of Jackson and Hinds County. She attended Jackson State University for her undergraduate degree and Mississippi College School of Law. She was sworn in July 2020 and has served as the Youth Court Judge since that time.

As of July 2025, Judge Hicks has 236 children in state custody and 720 children in in-home or kinship placements on her case docket.

ADVOCATES

CASA exists to give children in foster care a voice. Our advocates give foster children a voice each day in court, in team meetings, and in planning for their futures. Advocates complete at least 30 hours of training including court observation and complete full background checks to become an advocate. Each year advocates must also complete at least 12 hours of continuing education to grow their knowledge-based and learn best practices in foster care, trauma-informed techniques, and understand what resources are available to support their cases.


CASA SUPPORTING CAST



Individual Donors: \$18,308


National CASA Support: \$34,739

BECOME THE HERO IN A CHILD'S STORY

The Court Appointed Special Advocate (CASA) serves by judicial orders of the Hinds County Youth Court. A CASA Advocate serves on a volunteer basis as an independent advocate for the child's best interest and monitors the case until permanency is achieved. The CASA Advocate is directly responsible to the CASA Executive Director and must adhere to the rules and guidelines of the National CASA Standards.

QUALIFICATIONS

- At least 21 years of age
- No recent or current involvement in a case with the MS Department of Child Protection Services (MDCPS)
- Not an active foster parent in Hinds County
- No convictions or pending charges for a felony or misdemeanor involving a sex offense, child abuse/neglect, or related acts that would pose risks to children or to the CASA program's credibility
- Completed CASA Volunteer Application Form
- You have listed on the application all previous names used.
- You have listed on your application three references for a reference form to be completed
- Participated in a face-to-face interview
- Submitted to and pass a background checks
- Verified social security number
- Possess good oral and written communication skills
- Access to a computer and knowledge of word processing programs

TRAINING REQUIREMENTS

To become a volunteer advocate, you must complete thirty (30) hours of training. Attendance and completion of training is mandatory. The syllabus includes information pertaining to child abuse and neglect, the legal and social service systems, permanency planning and advocacy. Training also addresses practical issues related to case advocacy, such as policy and procedures, the court process and communication/negotiation skills. Upon successful completion of the training, you will be appointed as an officer of the court in a swearing-in ceremony before a Youth Court Judge.

CASA COMMITMENT & REQUIREMENTS

As an advocate, you will be assigned one case at a time requiring approximately 5-15 hours per month. The advocate's role is to inform the court of all findings related to the case and provide an assessment as to what is in the best interests of the child. As a part of this commitment, advocates must meet with the child(ren) at least monthly, and should communicate with interested parties such as parents, foster parents, school personnel, therapist, to learn about the dynamics of the case. You must also attend all court hearings and appropriate interagency meetings regarding the child. Hearings take place every three to six months and advocates are required to submit a monthly activity report to the Advocate Supervisor.

Advocates are required to submit formal reports to the court detailing your findings and observations. Court reports are due to the Advocate Supervisor no later than one week prior to the scheduled hearing.

An additional 12 hours of in-service training per year are required to maintain active status as an advocate.
